Summary and Rationale

Target Audience(s)

Target audiences are students majoring in communication sciences and disorders who may or may not want to pursue a master's degree in speech language pathology but wish to earn additional clinical experience and/or opportunity providing services to individuals with a communication disorder either prior to applying to a graduate program or instead of applying to a graduate program and could use their degree and SLPA certificate to obtain the SLPA certification from ASHA.

Evidence of long-term need

Historically in the state of Wisconsin some rural communities, specifically school districts and birth to three settings have not been successful in hiring an ASHA certified speech language pathologist to meet the needs of individuals who are eligible for federally funded speech and language services. There is a shortage of certified speech language pathologists in this state. In addition, there is a shortage of speech language pathologists across the country. According to the Bureau of Labor Statistics (2021), employment of speech-language pathologists is projected to grow 21 percent from 2021 to 2031, much faster than the average for all occupations.

Because of the growing shortage of certified speech language pathologists in meeting the needs of people who have communication disorders, many states have created a pathway to provide services for those needing treatment for communication disorders. That pathway is the Speech Language Pathologist Assistant license (SLPA).

Currently, the state of Wisconsin does not have a license for speech language pathologist assistants; however the need is there with growing caseloads and unfilled speech language pathologist positions across the state. Therefore, this proposal for a SLPA certificate is a step to providing additional training for students majoring in communication sciences and disorders who desire to work in the field as a SLPA in other states or in Wisconsin to assist speech language pathologists.

This SLPA certificate will prepare students to provide critical speech and language intervention in underrepresented communities and beyond. The SLPA certificate is an effort to be responsive to the needs of the communities in the state of Wisconsin, particularly those in rural settings. This certificate aligns well with our mission by providing educational opportunities responsive to the needs of communities, state, region and beyond as stated in the University Mission.

Statement of benefits to students

Students earning the SLPA certificate will be prepared to work in select settings as a speech language pathologist assistant under the supervision of an ASHA certified speech language pathologist without having to earn a master's degree in communication sciences and disorders. Additionally, this can give students an opportunity to earn additional experience prior to applying to a graduate program. It also gives students experience navigating an interdisciplinary collaboration while in those settings. Additionally, graduate programs across the region and beyond are often a barrier for students due to their competitive nature and cost. The SLPA certificate will provide an additional pathway for students, and they will be prepared to provide the much-needed services.
