

**UNIVERSITY OF WISCONSIN-EAU CLAIRE - STUDENT SENATE RESOLUTION
IN SUPPORT OF THE NON-ALLOCABLE
SEGREGATED FEE BUDGET**

1 WHEREAS, the University of Wisconsin Board of Regents requires that each campus have a
2 Segregated University Fee Allocation Committee (SUFAC) to appropriate portions of the segregated fees;
3 and

4 WHEREAS, the University of Wisconsin - Eau Claire Student Senate holds the responsibility of
5 appropriately allocating segregated fees; and

6 WHEREAS, Student Senate Finance Commission leadership meets with each non-allocable
7 organization individually while designing their budget; and

8 WHEREAS, the Student Senate Finance Commission reviews each proposed non-allocable budget
9 and gives Student Senate its recommendations; and

10 WHEREAS, the Finance Commission has completed its process of research, review, budget
11 presentation, upon which has adopted recommendations for the fiscal year 2023 non-allocable
12 Segregated Fees; and

13 WHEREAS, several organizations will continue to experience loss of revenue and increased costs
14 into the next fiscal year; and

15 WHEREAS, loss of revenue is primarily attributed to the decrease in enrollment that is projected
16 for the next fiscal year; and

17 WHEREAS, increased operating costs are primarily attributed to the lingering effects of the COVID-
18 19 pandemic on the economy, inflation, and contractual obligations associated with operating costs; and

19 WHEREAS, in the cases of Children’s Nature Academy, Recreation and Sports Operations, and
20 Transit, increases to the segregated fee is directly related to increased services and opportunities for
21 students; and

22 BE IT THEREFORE RESOLVED that Student Senate adopts the non-allocable budget
23 recommendation (Attachment “A”); and

24 BE IT FURTHER RESOLVED that the Student Senate adopts the non-allocable Segregated Fee of
25 \$1,412.95 representing a 2.94% increase in the non-allocable Segregated Fee from the previous year; and

26 BE IT FINALLY RESOLVED that upon passage, President Mikoulinskii will transmit a copy of this
27 bill to Dr. James Schmidt, Chancellor; LaRue Pierce, Dean of Students; Dr. Patricia Kleine, Provost and
28 Vice Chancellor, Academic Affairs; Olga Diaz, Vice Chancellor, Equity, Diversity, Inclusion and Student
29 Affairs; Grace Crickette, Vice Chancellor, Finance and Administration; Billy Felz, Interim Vice Chancellor,
30 Enrollment Management; Tracy Drier, Director, Budget and Resource Planning; Jacqueline Kriesel,
31 Controller, Administration & Finance; Kristin Schumacher, Director, University Centers; Evan Weiher,
32 Chair, University Senate; Grace Arrigoni, Student Body President, UW Eau Claire-Barron County; Gary
