1 WHEREAS, the University of Wisconsin-Eau Claire (UW-Eau Claire) Student Senate is the official 2 voice of the student body; and 3 WHEREAS, a coalition of student leadership, primarily led by UW-Steven's Point and UW-Eau 4 Claire, facilitated the drafting of a constitution for a statewide student governance organization in the 5 21-22 academic year; and 6 WHEREAS, the UW-Eau Claire Student Senate passed a resolution in support of statewide 7 student governance within 65-R-14 (attachment "A"); and 8 WHEREAS, upon the legislative approval of 9 comprehensive UW system schools, this 9 organization and its respective constitution shall be ratified; and 10 WHEREAS, the UWSSGA constitution provides guidance regarding the procedures and 11 membership criteria for each respective campus and the overarching statewide organization 12 (Attachment "B"); and WHEREAS, the organization shall allow for stronger communication and collaboration amongst 13

WHEREAS, the organization shall allow for stronger communication and collaboration amongst system student governances, particularly through the capacity of regular meetings with other shared governance entities; and

WHEREAS, specifically, involvement in this organization shall benefit all system students in the facilitation of more unity to counteract issues of equity and generally dismissed student issues; and

WHEREAS, a more generalized description of the organization's benefits also includes relevant historical context and rationale behind the organization (Attachment "C"); and

BE IT THEREFORE RESOLVED, the 66<sup>th</sup> Student Senate session echoes the sentiments of 65-R-14 to support the creation of and participation in the UWSSGA; and

BE IT FURTHER RESOLVED, upon successful passage of this bill, the constitution of the UWSSGA shall be considered ratified and adopted by UW-Eau Claire; and

BE IT FURTHER RESOLVED, the UWSSGA constitution shall also replace part 10-14 of the Intergovernmental Affairs Bylaws; and
