1 WHEREAS, the bylaws of the University of Wisconsin-Eau Claire (UW-Eau Claire)
2 Student Senate provide specific policy and procedural interpretations of the Student
3 Body Constitution; and

4 WHEREAS, the most recent alterations to the bylaws were made in the 66th
5 Student Senate session; and

6 WHEREAS, in order to operate in an ethical and equitable capacity, Student
7 Senate must continuously review the existing systems in this organization; and

8 WHEREAS, the new Student Senate bylaws, as reflected in attachment "A",
9 provide updated language for the Intergovernmental Affairs Director responsibilities; and

10 WHEREAS, this change allows flexibility for the Intergovernmental Affairs Director
11 and Commission to operate as best as possible; and

12 WHEREAS, this change also contributes necessary demand to better the mission
13 of the Intergovernmental Affairs Commission; and

14 BE IT THEREFORE RESOLVED, that the Student Senate of the UW-Eau Claire
15 officially amend the bylaws at Chapter III, Section 3, Part 10, Line Item 12 reflected in
16 attachment "A;" and
