 4 appeals for their Fiscal Year 2023 ending balances; and

5 WHEREAS, The Finance Commission has met and deliberated to decide the reallocation  
 6 of Fiscal Year 2023 Year-End Balances to Organized Activities.; and

7 WHEREAS, The Finance Commission has voted unanimously on all Year-End Balance  
 8 appeals; and

9 WHEREAS, the Finance Commission will reallocate Forensics, \$3,500 of their Fiscal Year  
 10 2023 Year-End Balance; and

11 WHEREAS, the Finance Commission will reallocate Forum \$2,000 of their Fiscal Year 2023  
 12 Year-End Balance; and

13 WHEREAS, the Finance Commission will reallocate ESM \$9,712 of Powwow's Fiscal Year  
 14 2023 Year-End Balance; and

15 WHEREAS, the Finance Commission will reallocate Student Office of Sustainability,  
 16 \$31,000 of their Fiscal Year 2023 Year-End Balance; and

17 WHEREAS, the Finance Commission will reallocate Student Organization Fund \$6,100 of  
 18 their Fiscal Year 2023 Year-End Balance; and

19 WHEREAS, the Finance Commission will reallocate Student Senate – General Operations  
 20 \$8,000 of their Fiscal Year 2023 Year-End Balance; and

21 WHEREAS, the Finance Commission will reallocate University Activities Commission  
 22 \$2,000 of their Fiscal Year, 2023 Year-End Balance; and

 24 Summary; and
