Approval of Meeting Minutes from 04/18/22

Meeting minutes approved unanimously.

REPORT: President – Jaden Mikoulinskii

It has been my immense honor and privilege to serve in this position for the 65th Student Senate session. While we do have one final meeting yet under our current purview as the Executive Board, I thought it would be appropriate to highlight some of the primary accomplishments from my office this year. Please note that all of these were projects I initiated with plenty of support from our Student Senate team.

- -Establish the first ever Blugold Welcome Week outreach event for Student Senate -- The Senate Social
- -Reimagine route frequency of Bus 9 and 19, in addition to re-raising the overarching concern of Sonnentag access
- -Re-enter the conversation about a universal laptop policy to include UWEC-Barron County
- -Address the four year-long issue of Barron County's lack of access to infrastructural resources, student affairs-centered programs, and Senate access
- -Secured space and resources for the Intersectional Women's Center
- -Propose the potential for the Equity in Student Matters Commission to be recognized as an Organized Activity, in addition to creating specific criteria and language for the process



- -Support efforts for Library Advocacy Committee and define their parameters
- -Make the January Shared Governance Symposium come to fruition, in addition to the creation of the UWSSGA alongside President Will Scheder (UWSP)
- -Increase collaboration with other UW-System Schools through hosting an October Shared Governance visit
- -Continuously support intern and commission member recruitment efforts
- -Insight support for the University Activities Commission Spring Concert
- -Support student activism efforts in response to the Office of Multicultural Affairs and Blugold Beginnings merger
- -Attend events or meetings for every Student Senate Commission
- -Establish criteria for mascot image and likeness
- -Connect with community landlords to combat early leasing practices
- -Support the Fall Community Walkthrough and UW Lobbying Day events
- -Heavily communicate and guide efforts within the Internal Affairs Committee regarding Bylaw change efforts
- -Plan and execute the Fall Student Senate retreat
- -Encourage collaboration between the Student Organizations Commission and the Enrollment Management Office ("Hey Brenden, let's talk about my meeting with Billy Felz")
- -Find opportunities to connect with the University Executive Team, Eau Claire County Health Department, and more
- -Work with individual Senators on various projects, including raising the need for a Blugold Guide, supporting "Un-Housed Week" initiatives, and the student athlete parking survey
- -Secure space and establish priorities for the Student Sustainability Resource Center (SSRC)
- -Speak at various events, including Opening Day, Sonnentag Press Conferences (x2), etc.
- -Promote sustainability initiatives in the Science and Health Science Building, as well as Sonnentag
- -Reinvigorate the formerly dissolved "Motivation Monday" event

REPORTS: Board of Directors

Academic Affairs Commission Director - Elizabeth TenBarge

I have been so grateful to have such an active commission this past year. We have worked on so many projects and provided feedback on a multitude of changes. I am going to go over some of the major projects that AAC has done this year, as well as steps that AAC has taken to improve the future commission as well.

The largest project that we accomplished was the reworking and updating of the Blugold Commitment Differential Tuition. With the assistance of the wonderful Mary Hoffman and Stephanie Jamalske, we reworked the current application, review forms, and student senate bylaws. We also created a separate committee that will run every year to provide a more knowledgeable student group to review all proposals. This year was a great trial of this, and with the added information on the review form, as well as a few training sessions for the student reviewers, this year was a success. I am excited to have these improvements be long-lasting as the committee ran efficiently and was also able to provide meaningful feedback that was appreciated by staff. On the same BCDT project, I made updates to clarify and revise the Student Senate Bylaws to better reflect the process that we currently have. With Stephanie Jamalske's informed eye, we were able to produce the bylaw revisions that will be coming up later tonight. Our commission has made huge strides in understanding, clarifying, and acting on BCDT this year, which I hope will continue in the future. f

Next, through the University Liberal Education Committee, we have worked on updating the R1 rubric which is used to evaluate EDI courses. The Academic Affairs Commission has helped to give feedback, facilitate gathering other students' input, and provide recommendations. We took a deep look at all aspects of the rubric, and went to other organizations to have long conversations about the needs of the rubric, student body, and university as a whole. We were able to have critical conversations about what standards we should be expecting out of our students, and are trying to now implement the feedback that



we received. As we are nearing the end of the semester, ULEC is working hard to see the rubric edits completed, with a timeline of reviews happening in the fall. This process is an incredibly important one that can shape what classes are offered and the standards that our students graduating have.

Speaking of student input, each semester the Academic Affairs Commission holds an open forum to learn about concerns that students have with their academics. Through the feedback we received last semester, we were able to create initiatives and projects that would address those concerns. We held our open forum for this semester with a few new ideas that we implemented to try and make our forums more accessible. Instead of just doing our forum in Davies, we expanded into the main thoroughfare of Hilltop. We also provided an online option for students to utilize, which will hopefully be appearing on the Academic Affairs website soon. We didn't receive many student complaints; however we did receive positive feedback about student's academic experiences for this year. In the future, I would recommend that the Academic Affairs Commission look into doing professor recognitions for having a positive impact on students, as some of the stories we heard should be recognized.

Academic Affairs has also made strides in increasing research opportunities for students. I personally am the student officer on the NCUR team and am excited to continue providing a student perspective as we get closer to the big event. The Commission has been focused on exploring the misconceptions surrounding research, and will be doing a seminar at CERCA on "How to Get into Undergraduate Research" which will be recorded and put on the UWEC website for future students. This session will be taking place tomorrow at 2PM in the Dakota Ballroom. We hope to make this seminar an annual event, and possibly putting this presentation on at orientation. In future sessions, we have set up a plan to create more opportunities for research, including utilizing sites like handshake to make research experiences more accessible for all students.

There are many other smaller projects that AAC has worked on this year, but I will turn to the largest projects that will be accomplished in the future.

At the beginning of the session, we worked on the four-year graduation guarantee. We created advertisements and worked to create a larger awareness of this great program. Through this program, there is still so much to be done in educating the student body about this opportunity and working with ARCC. In the future, the commission will work to provide more materials to both students and advisors and collaborate with ARCC to determine how we can best support this program.

Another project that AAC will continue in the future is an update of the Gold for Blugold website. The website currently has some accessibility issues that we have started to address which the next director will have to bring to fruition next session in coordination with the Foundation and the ITC Director.

I have been extremely grateful to be in my position this year and work with so many amazing students, faculty, and administrators. I am proud of the work that my commission has done, and am extremely optimistic about where the Academic Affairs Commission will go in the future.



Executive Board applications are open for this upcoming year, so please come and talk to me about the Academic Affairs Directorship if you are somewhat interested. I do think that this commission is the best commission, and it allows for so much hands on action and real change to occur if you put in the work. Communication Commission Director - Yoshi Gaitan

We included a posting for Senators (office hours for exec too) (commission updates, in case you missed one, and the usual legislation, minutes and agenda which too believe it or not; needed to be updated with our new logo! Overall; it was a visual space that we created as well as the space outside the office.

On the topic of updating; a large project that I wanted to take on and boost as much as possible was the Student Senate site. There was information on there that had not been relevant for a number of years. I went by; fixed our directors' sites; added relevant pictures, information, meeting times, pronouns, and other smaller things that I felt were necessary. Besides this I also created a page for Motivation



Monday and a page that is nearly ready to go live for current Student Senate Members that will hopefully prove to be useful in our new session. This site will be an access point to find information that isn't always written down or repeated; just so you don't forget or feel that you are behind because you missed one meeting or piece of legislation. I also added a survey that is currently on our site and has been for a while. This survey s Jaya place where student can leave feedback and comments and was created to be a place where students who do not feel comfortable speaking during our office hours; we currently have a couple of submissions.

The site by far is something that I am incredibly proud of whipping back into shape because when a majority of students do not know what the student senate is; we direct them there, which has been full of outdated information. We also cultivated a majority of the election media and handled distributing important information to the student body this semester such as the successful candidate forum. There were several postings that comms also created and distributed throughout this semester.

Besides what Comms did I also was able to gain so much knowledge such as collaborating on Legislation, lobbying, and attending senate related social and professional events. There are so many things that comms did that maybe you didn't notice through a large bill or intense media coverage but I am very proud of the change we were able to create and do this semester and how many more students we were able to reach (:

Intergovernmental Affairs Commission Director- Bailey Carruthers

Let's take a look back into the accomplishments of the IGA Commission this past session! The 65th session began strongly for the IGA Commission, with the initial passage of the Fall Legislative Priority Summary, and 2 pieces of legislation 'In Condemnation' of action within the state legislature that would've directly impacted the UW System, its students, and the future of the institution. We also reinstated the historical 'Fall Community Walkthrough', where university administration, city government officials, students, and local police enforcement went into surrounding residential areas where a large portion of our student population lives, and discuss ways to alleviate common problems. From this came 3 large developments in terms of accessibility, safety, and sanitation surrounding UW-Eau Claire. We also partnered with the ESM Commission to hold a donation drive for Afghan Refugees in Fort McCoy, and donated over 100 articles of clothing for all genders and age groups, as well as a plethora of hygiene items, and individually packaged water.

Starting off strong in the Spring Semester we began a partnership with the Chippewa Valley League of Women Voters, held voter registration drives, and held a massive campaign to increase knowledge to students living on-campus of how to vote. In February I attended the Chippewa Valley Rally along with Vice-President Justin Paul Schilling, where we developed professional connections and met with state legislators. The IGA Commission during early Spring Semester went on to author two more pieces of legislation "In Condemnation" of hurtful and hateful bills proposed by the state legislature that would severely impact the UW System, its students, and faculty. In late February I also met with Governor Evers, where we spoke on great Chippewa Valley developments and projects, including funding for the Phase II development of the Science and Health Sciences building. During this meeting, I was able to discuss with him our legislation in response to state bills that would be arriving at his desk in the following months and received positive reassurance that he would keep the student perspective in mind. In late March, to much success, we held the IGA Candidate Forum for local elections occurring the following week, and heard great feedback from university administration, candidates, and students, and are excited to continue the tradition with the upcoming state elections in the fall.

In all, the IGA Commission accomplished a lot of great work this session. Apart from holding multiple events, tabling opportunities, and authoring legislation, the IGA Commission was able to re-cement its position as a non-partisan, organized, powerhouse that advocates for students at a campus, city, state, and federal level. I am so proud of all of the accomplishments that this commission has completed, and despite 5, yes 5, canceled events this year, the IGA Commission persisted with nothing but grace, optimism, and pure excitement. A special thank you to Alicia Long and Hannah Kelly, you both helped immensely with projects, and keeping me sane in the chaos.

And the fun has not ended for the IGA Commission! We still have the Dash and Bash, which will take place one week from tomorrow, Tuesday, May 03. I hope to see you all there!! The IGA Commission will be having an IGA End of Year Celebration on Wednesday, May 04 at 5:00 PM including food, games, and superlatives on those special "You're a Star" certificates you used to get in Kindergarten. I love you all so much, even those it doesn't seem like it sometimes.



Student Office of Sustainability Commission Director - Maddie Loeffler

Greetings, fellas. This year has been interesting, to say the least. We've had some great successes, a lot of struggles, and so much confusion. Thank you all, especially those who have participated in the SOS in one form or another. Your support has kept us going.

We started out the academic year tripping over our feet, or rather, administration's feet. Initiatives were being shot down left and right, and we were having difficulty understanding our role in campus sustainability. The first item on our priorities summary from the fall is "provide off-campus composting services to students". The SOS Commission and Student Senate Body used their votes to support this, but alas, it did not come to fruition. We've learned and grown a lot since then and have concluded the session with the grand opening of the SSRC, thanks to the dedicated SOS Exec Board, Student Body President, and SOS Commission members. Our role on campus is based in advocacy. People are our power, and student voices are more powerful than we realized.

Part of the SOS's purpose is to allocate the Green Fund. Here are the projects that the SOS allocated money toward this year: Tree Campus Higher Education (which funds the campus arboretum), Renewable Connect (which powers Davies with renewable energy), two orders of locally-printed SOS merch designed in-house by our design intern, student internships (including five SOS executive board members and one working with the City of Eau Claire, DECI, and Beaver Creek Reserve), fall and spring subsidies for student tickets to the BANFF Mountain Film Festival, 10 student artwork commissions for the SSRC, Soles for Souls, a social media giveaway, Earth Claire, Pack it up, Pass it on (which will take place at the end of this semester for students to dispose of unwanted items and take what they need), and potentially LEED and WELL Certification of the Sonnentag Complex.

The other primary goal of the SOS is to educate the student body and advocate for campus and community sustainability. I cannot begin to list all of the ways that SOS members have made a difference on campus, but I will give you a snapshot: we participated in the new Science Building Committee and will continue working to push for sustainable infrastructure, we represented students in the Chancellor's Advisory Committee on Sustainability and Climate Action, we worked throughout summer and fall semester to help implement the BluBox Program, we collaborated with campus and community partners to bring groups together for Earth Claire and other Earth Week initiatives, we advocated for the Sonnentag complex to be as sustainable as possible, we curated a space for students to access programming opportunities and collaborate on sustainability and climate action initiatives, and we pushed for sustainability to be a priority at the UW System level.

That was a mouthful, so I'll keep the rest short: thank you all for your support over this past year, and I look forward to seeing what the next session of the SOS has in store.

Hello everyone! Happy Monday! This semester I have been analyzing relations between students and landlords, updating the Housing Guide for Off-Campus Students, and planning HOUSE Day 2022 for this fall.

I started off this semester by creating a Qualtrics survey that was sent out to all off-campus students. As many of you may know, this survey had over 300 participants and included questions regarding how landlords and property owners treat their tenants. The results from this survey have shown that there is a disconnect between the two parties and many students are unaware of the resources available to them. This includes resources such as Harry Hartel, the legal attorney for students, reduced on-campus housing

during Unhoused Week, and more. I have put in my transition materials that the next Housing Intern should work to make these resources more known and accessible. Many of these resources will also be included in the new Handguide for Off-Campus Students.

The Off-Campus Housing Guide has been something that has taken up most of my time this semester. Previous Coordinator Katie Loff had many meetings with Vice-Chancellor Grace Crickette and Attorney Harry Hartel in order to get the correct information for the Housing Guide.
