DEADLINE: This exemption request form, plus any required additional documentation must be submitted by the **first day of classes**. Housing and Residence Life is obligated to enforce the Board of Regence Policy 24-2, and the terms and conditions of the Housing Contract requiring first and second year students to live in University residence halls. Students who are aged 21+ or whose high school graduation date is two years prior to the first day of classes are not required to live on campus (unless the student has submitted a housing contract, and failed to cancel prior to the May 1<sup>st</sup> deadline.)
