

**ARTICULATION AGREEMENT
BETWEEN
UNIVERSITY OF WISCONSIN-EAU CLAIRE
AND
CHIPPEWA VALLEY TECHNICAL COLLEGE**

This Agreement is entered into between **Chippewa Valley Technical College** (hereinafter sending institution), and the **University of Wisconsin-Eau Claire, Eau Claire, WI** (hereinafter receiving institution). This Agreement and any amendments and supplements, shall be interpreted pursuant to the guidelines set forth in the University of Wisconsin System Administrative Policy 140 (SYS 140) "UW System Guidelines For Articulation Agreements Between UW System Institutions and WTCS Districts" as well as 135 (SYS 135) "University of Wisconsin System Undergraduate Transfer Policy". Both institutions agree to maintain accreditation by the Higher Learning Commission (HLC) and any other accreditation currently in existence pertaining to degree programs articulated via the transfer agreement.

The sending institution has established a **Criminal Justice Law Enforcement Academy** (hereinafter sending program), and the receiving institution has established a **B.A. or B.S. in Criminal Justice** (hereinafter receiving program), and will facilitate credit transfer and provide a smooth transition from one related program to another. It is mutually agreed:

I. Admission and Graduation Requirements

- A. The sending institution agrees to admit current UWEC Criminal Justice students after completion of a minimum of 60 credits in their program.
- B. The receiving institution's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.
- C. Students must fulfill the graduation requirements at both institutions to include:
 - 1. Liberal Education Core
 - 2. Students at UW-Eau Claire will be required to complete a minimum of 30 credits in residence for a bachelor's degree at UW-Eau Claire.
 - 3. Meet all other graduation requirements as listed in the UWEC catalog the student is under.
- D. Students must complete the entire sending program and meet the receiving institution's admission requirements for the agreement to apply.

II. Transfer of Credits

- A. The receiving institution will apply a maximum of 12 of the 21 credits from the sending program. A total of 108 credits remain to complete the receiving program. (note: additional credits may need to be taken to reach the 120 credits needed for graduation.)
- B. Courses will transfer as described in the attached Program Articulation Table.
- C. Elective courses taken or substituted at the sending institution and sending program not listed in this agreement will be reviewed on a case-by-case basis and determined how they may apply to the degree at the receiving institution.

III. Implementation and Review

- A. The Provost, Dean, Department Chair or designees of the parties to this agreement will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.
- B. Any marketing of this agreement will be subject to the prior approval of both parties and will adhere to each institution's standards for the use of its name and logo. Each institution will assume responsibility for appropriate marketing to reach its student population. Each institution may provide a link to this agreement and/or the other institution on its website, with notice to the other party.
- C. Both parties agree that failure to maintain regional accreditation will be grounds for termination of the agreement. Failure to maintain accreditation required by the specific academic program(s) referenced in this agreement will be grounds for exclusion of that program from the agreement.
- D. This Articulation Agreement is effective on 6/1/2019 and shall remain in effect until the end date of 5/31/2024 or for five years, whichever occurs first, unless terminated or amended by either party with 90 days prior written notice.
- E. The college and university shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- F. This Articulation Agreement will be reviewed by both parties beginning 12/01/2023 (within six months of the end date).
- G. When a student enrolls at the receiving institution following this agreement, the receiving institution will encode any course waivers and substitutions.
- H. This articulation agreement applies only to the receiving program in effect Summer 2019 until revised.

***Students pursuing a B.A. degree can fulfill the S1 foreign language requirement two ways:**






- Achieve a score on the foreign language placement test that qualifies the student to enter the 201-level course in a foreign language.
- Earn a grade of at least C (not C-) or a mark of S in a 102-level foreign language course (or AIS 112 or AIS 122/Lang 122 or GSD 103)

****Students pursuing a B.S. degree can fulfill the S2 mathematics requirement three ways:**

- Achieve a score on the mathematics placement test that qualifies the student to enter MATH 114.
- Earn a grade of at least C (not C-) or a mark of S in MATH 111, MATH 112, or MATH 113.
- Achieve a satisfactory score on the MATH 112 competency test. This test may be attempted no more than two times.
